TO TRUST AGREEMENT AND INDENTURE OF RESTRICTIONS OF FOUR SEASONS SUBDIVISION

WHEREAS, it is recognized that in order to exercise the powers, rights and privileges granted to the Trustees and to discharge the duties imposed upon them, it may be necessary from time to time, for the Trustees to borrow sums of money, and

WHEREAS, said Agreement provides that it may be amended and modified.

NOW, THEREFORE, the Owner, pursuant to the reservation of power to amend, as set forth in the last paragraph of Article V of the Agreement, does hereby adopt the following amendments to the Agreement:

1. Article III shall be amended by adding thereto the following:

(A) The Trustees are hereby authorized and empowered to borrow or raise money for any of the purposes of the Agreement and, from time to time, to draw, make, accept, endorse, execute, issue and grant promissory notes, drafts, bills of exchange, debentures and other negotiable or non-negotiable instruments, evidences of indebtedness and agreements; to secure the payment thereof, and the interest thereon, and the performance thereof by mortgage upon or pledge, conveyance, assignment in trustof, the whole or any part of the assets owned by said Trustees, whether at the time owned or thereafter 800K5595 PAGE 207

acquired; and to sell, pledge or otherwise dispose of such securities or other obligations of the Trustees for the purposes set forth in the Agreement; '

- (B) To exercise any and all powers necessary, convenient or proper to carry and effect any of the foregoing purposes; and to designate one or more Trustees to act on behalf of the Trustees; and said Trustees may exercise this power and designation by means of a resolution of the Board of Trustees at any regular or special meeting thereof.
