Remove the following text from Article 1:

Whenever any vote for any purpose is required under this indenture the record owner or owners of each residential lot shall be entitled to one (1) vote in the aggregate, and the record owner or owners of each lot improved with a multiple family apartment building shall be entitled to one (1) vote per family unit contained in each building.

And replace with the following text to be added to Article 1:

Whenever any vote for any purpose is required under this indenture the record owner or owners of each residential lot shall be entitled to one (1) vote in the aggregate, and the record owner or owners of each lot improved with a multiple family apartment building shall be entitled to one vote (1) per each such building.

In all other respects, the TRUST AGREEMENT AND INDENTURE OF RESTRICTIONS OF FOUR SEASONS SUBDIVISION, as amended, shall remain in full force and effect.
